##### **1 Approval of the annual report for the financial year 2025**

###### **1.1 Approval of directors' report**

The board of directors proposes that the directors' report for the company's financial year running from 1 January 2025 to 31 December 2025 ("Financial Year 2025") shall be approved.

###### **1.2 Approval of the financial statements of the company**

The board of directors proposes that the financial statements of the company as of 31 December 2025, as audited by the statutory auditor Aeberli Treuhand AG, shall be approved, and that the audit report shall be acknowledged.

###### **1.3 Approval of the consolidated financial statements of the company**

The board of directors proposes that the consolidated financial statements of the company as of 31 December 2025, as audited by the statutory auditor Aeberli Treuhand AG, shall be approved, and that the audit report shall be acknowledged.

## **5 Re-election of the auditor**

The board of directors proposes the re-election of Aeberli Treuhand AG (CHE-101.652.973), in Zurich, as auditor of the company for a tenure of one year until the 2027 annual general meeting.

*Note: According to article 27 of the articles of incorporation, the general meeting annually elects the company's auditor for a tenure of one year.*
